Sir/Madam,

In continuation to this office letter No.MCI-34(41)(E-69)/2019-Med./114003, dated 16/05/2019 and your letter No. HFW-23099/79/2019/M/1093, dated 20.05.2019 (received from the Principal of the college vide letter dated 21.05.2019) furnishing required undertaking, I am directed to convey the formal permission of the Board of Governors for establishment of a new medical college at Diamond Harbour, West Bengal in the name and style of "Diamond Harbour Government Medical College and Hospital, West Bengal" with annual intake of 100 MBBS students for the academic year 2019-2020 under Section 10A of the Indian Medical Council Act, 1956.

2. This permission of the Board of Governors in supersession of the MCI accorded initially for a period of one year and will be renewed on yearly basis subject to verification of achievement of annual targets as indicated in your scheme. This process of renewal of permission will continue till such time the infrastructure and expansion of hospital facilities are completed as per norms of Medical Council of India and the college is recognized. The next batch of students shall be admitted only after obtaining permission of the Board of Governors in supersession of the MCI.

3. Admissions made in violation of the above condition will be treated as irregular and action will be initiated under IMC Act & Regulations made there under.

4. The Government Medical Colleges (except those located in J & K States) shall contribute 15% of MBBS seats for which the renewal permission is granted for all India quota.

5. Discrepancies, if any, may be immediately brought to the notice of the Board of Governors in supersession of the MCI and the State Govt.
