- 4. It is mandatory for the Government Medical Colleges to contribute 15% of MBBS seats and 50% of Post Graduate Broad Specialities (MD/MS) for All India Quota respectively, to MCC of DGHS for conduction of counselling as per the directions of the Supreme Court.
- 5. It is mandatory to develop a website on the medical college/ institution and display all the information of the college, courses offered, faculty available and their experience of the last 5 years, students joined, and affiliating university and to display the hospital services, facilities available and the equipment in each specialty, also showing OP and IP census including births and deaths as per the municipal/ Govt. records.

6. Further, in addition to the same the applicant should ensure that the following criteria are met:

- a. The Medical Assessment and Rating Board (MARB) reserves the right to withdraw/cancel/revoke the Letter of Permission if it comes to the notice that the permission has been obtained from Medical Assessment and Rating Board (MARB) by misrepresentation of facts or fraud.
