

Terms & conditions

Manufacturers/direct importers/ authorized dealers, distributors are eligible for quoting in this tender.

1. The rate should be quoted in both figures & words. Rates quoted should be all inclusive of delivery charges to the concerned department including installation & packing charges etc. All applicable charges should be mentioned separately including GST.
2. Earnest money amounting Rs.10, 000/- (ten thousands only) should be paid through demand draft only in the name of DIAMOND HARBOUR GOVERNMENT MEDICAL COLLEGE AND HOSPITAL ROGI KALYAN SAMITY.
3. The tenderers must submit their tender in two bid method. The main envelope should contain technical bid in one envelop and financial bid in other envelop. All envelops must be properly sealed.
4. Financial bid of those bidders will only be opened who will qualify in technical scrutiny by tender selection committee.
5. Only successful bidder will deposit of Rs. 2000/- (twenty thousand) in the form bank guarantee only as a security deposit for two year from the date of supply.
6. The tenderer shall be bound for total replacement of the supplied equipment with a fresh supply of equipment if the item is found to be defective/not as per given specification.
7. Specification & brochure is to be submitted along with the tender
8. The tenderers must accompany with all the papers/documents along with the paper.
9. The tendering authority also reserves the right to accept/ reject any time in the tender process without assigning any reason what so ever.
10. Payment will be made only after the delivery of the articles and satisfactory certification by the concerned authority fixed by the administration. No request for advanced or part payment will be Considered
11. in case of rejection of any supply on quality grounds or failure or refusal to replace the contracted items with the specified time so according to specifications/quality, the hospital administration will have the authority to recover the losses, if any, by making deductions from any pending claim of the supplier in respect of same tender or any past/future tender.
