### RECRUITMENT NOTICE

As per approval of the Director of Medical Education, Department of Health & Family Welfare, Govt. of West Bengal, vide e-file no. HFW-46030/34/2022-MC SEC-Dept. of H&FW and as per approval from the AO, VRDL Scheme, DHR-ICMR by Department of Health Research, ICMR (Indian Council of Medical Research), New Delhi, suitable candidates are invited to fill up the 1 (one) no. post of **Scientist B (Medical)** under VRDL project at Dept. of Microbiology, DHGMCH, Diamond Harbour on purely temporary and contractual basis for the period of six months which can be renewed on six months interval considering satisfactory services rendered by the candidates.

#### 1. Selection Process:

- The candidates will be selected in two stages:
  - i) Verification of Academic Qualification and Work experience in the relevant field (Total Marks - 90).
  - ii) Viva-Voce (Total Marks-10).
- Essential Qualification :
 

MBBS / BDS / B. V. Sc. & AH recognized by MCI / DCI / VCI. respectively Or BDS / B. V. Sc. degree with one year experience.
- Desirable Qualification :
  - i. MD / MDS / M. V. Sc. in a related subject from a recognized University.
  - ii. Ph.D in a related subject from a recognized Institute.
  - iii. Additional Post-doctoral research / training experience in relevant subjects in recognized institutions.
  - iv. Preference will be given to candidates having experience in virology / microbiology / related laboratory works, NABL accreditation, and knowledge of computer.
  - v. Two years research experience in relevant subject after obtaining essential qualification.
  - vi. Higher qualification & experience more than the essential qualification in the relevant discipline will be an advantage for short listing.
- The age of the candidates minimum 21 years and maximum 40 years as on 01.01.2026.

#### 2. Distribution Patterns of Marks:

Calculation of the weightage on percentage of marks for Academic Qualification and Work experience in the relevant field required for selection are mentioned below:

- i) Secondary Examination OR equivalent examination- **Total Marks 20.**
- ii) Higher Secondary Examination OR equivalent examination- **Total Marks 20.**
- iii) MBBS / BDS / B. V. Sc. & AH recognized by MCI / DCI / VCI. respectively Or BDS / B. V. Sc. degree with one year experience- **Total Marks-40**
- iv) Experience- **Total Marks 10**

5 marks for each completed year will be calculated for Govt. organization & 2 marks for each completed year will be calculated for Private organization.

Salary as per DHR Guidelines: Rs. 56,000/- + HRA Increment as admissible as per DST norms.
